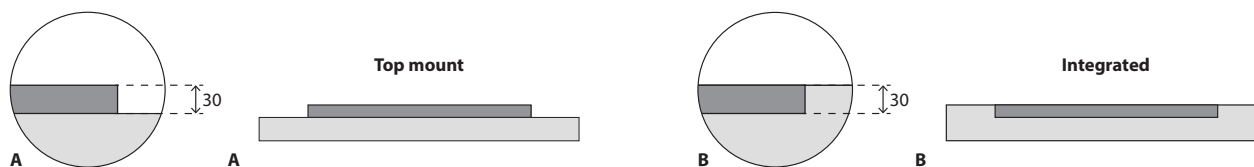

Corian® Casual products are not customisable and cannot be fabricated.



4. Material composition:

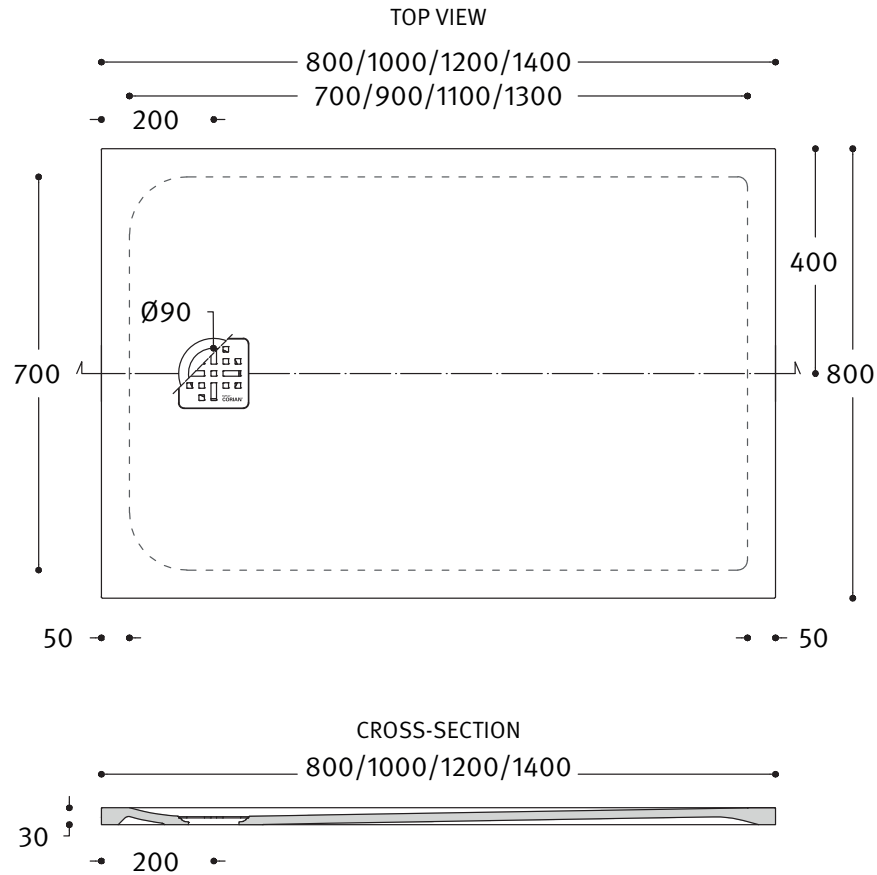
Corian® Casual shower trays are made with a composite material which consists of a base made of polyester resin and natural minerals and a hard polymeric surface layer made of polyester resin and ATH filler.

The surface layer provides optimal characteristics of resistance, hygiene, durability, reparability and the ability to completely renew the surface.

Corian® Casual products are made in Casual White colour, a close match to Glacier White colour of Corian®, in the following formats:



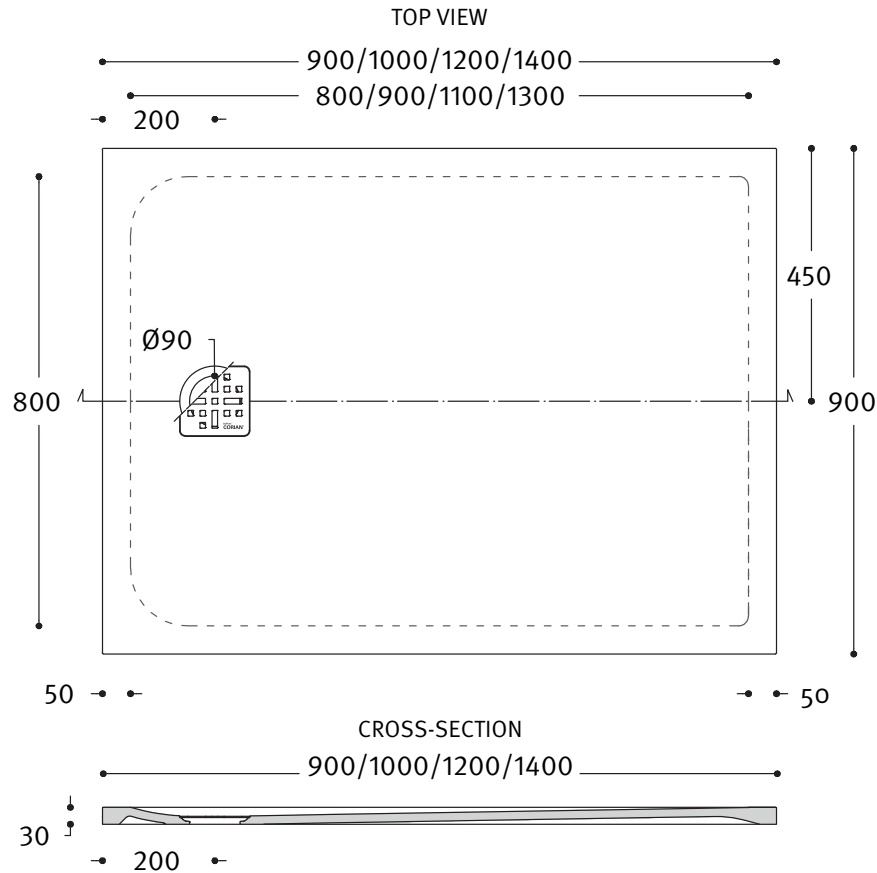

6. Dimensional tolerances:

Corian® Casual products have the following dimensional tolerance limits:

Thickness: ± 2 mm

Length: ± 3 mm

Warp: 2 mm

7. Installation:

Allow a minimum gap of 3 mm with walls and flooring. This is required to allow for expansion of the product.

The expansion gap should be caulked with silicone or polyurethane sealants to avoid water infiltration.
