## DUPONT™ CORIAN® CASUAL, SMART AND DELIGHT PRODUCT WARRANTY

DuPont de Nemours International Sàrl CH-1218 Le Grand Saconnex, Switzerland (hereafter called 'DuPont') warrants hereby, subject to the time limitations described under point 4, the following:

DuPont warrants to you, the owner of the original DuPont™ Corian® Casual, Smart or Delight installation, that DuPont will, at its discretion, replace or repair your DuPont™ Corian® product, if the product fails due to any product defect during the first two (2) years from the original date of installation of DuPont™ Corian®. This warranty does not cover products made by other suppliers.

### GENERAL TERMS AND CONDITIONS OF THE TWO (2) YEAR LIMITED PRODUCT WARRANTY

1. This warranty applies exclusively to interior decorative DuPont™ Corian® solid surface products.
2. This warranty does not cover:
  - A. Installation, it only covers the Product.
  - B. Any damage(s) caused by improper or inadequate residential or commercial use, care or maintenance; and
  - C. Any DuPont™ Corian® material modification or misuse; and
  - D. Installation and/or operation outside the material's interior environment specifications, ie. outdoor use; and
  - E. Physical, chemical or mechanical abuse; and
  - F. Damage from exposure to excessive heat transmission; and
  - G. Improper installation site preparation or site maintenance; and
  - H. Issues resulting from colour differences; and
  - I. Acts of God (events outside human control); and
  - J. Any other improper use of DuPont™ Corian® as stated in the use and care instructions in the 'Caring for DuPont™ Corian®' brochure.
3. Under the warranty DuPont will replace the shape only once.
4. To receive coverage under the DuPont™ Corian® 2 Year Limited Product Warranty, proof of purchase in the form of an invoice needs to be submitted with the claim. No invoice will mean no coverage.
5. Any DuPont™ Corian® replacement or repair needs to be first authorised in writing by DuPont or its duly appointed representative.
6. This DuPont™ Corian® 2 Year Limited Product Warranty applies only for:
  - A. Products purchased after 1 July, 2016 in Europe, the Middle-East and Africa; and
  - B. Shapes which have not been moved from their original place of installation; and
  - C. Shapes which were not showroom models; and
  - D. Shapes which are maintained according to the use and care instructions in the Caring for DuPont™ Corian® brochure handed over with the acceptance of this installation and available on [www.corian.com](http://www.corian.com)
7. If DuPont is unable to repair or replace, as applicable, a defective product which is covered by this DuPont™ Corian® product warranty, DuPont shall, within a reasonable time after being notified of the defect, refund the purchase price of the DuPont™ Corian® material only, as per limitations in point 4, provided the customer hands over the DuPont™ Corian® material to DuPont or its appointed representative.
8. **Limitations of warranty:**  
Neither DuPont nor any of its third party suppliers makes any other warranty of any kind, whether express or implied, with respect to DuPont™ Corian® solid surface. DuPont and its third party suppliers specifically disclaim the implied warranties of merchantability and fitness for a particular purpose other than interior or decorative surface use.
9. **Limitations of liability:**  
Except for the obligations specifically set forth in this warranty statement, in no event shall DuPont™ Corian® be liable for any direct, indirect, special, incidental, or consequential damages, whether based on contract, tort, or any other legal theory and whether advised of the possibility of such damages.
